### Full Member | \$25,000

Full Members receive one position on the Board of Directors. Full members may also serve on the Executive Committee as an officer or in an at-large position and are eligible to hold a committee leadership position.

### Sponsoring Member | \$10,000

Sponsoring Members receive one vote on issues before the general membership. Sponsoring Members may also serve on the Executive Committee as an officer or in an at-large position and are eligible to hold a committee leadership position.

### Associate Member

- Level 1 | \$2,500\*** (Less than 1,000 Texas employees)
- Level 2 | \$5,000** (1,000 or more Texas employees)

Associate Members receive one vote on issues before the general membership. Associate Members may also serve on the Executive Committee in an at-large position and are eligible to hold a committee leadership position.
